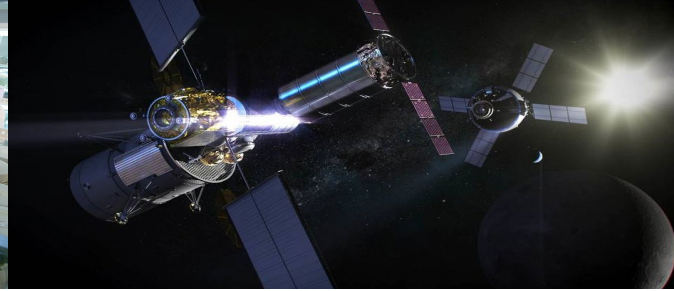

## SAMPLES OF CONTRACT EXPERIENCE

### **National Aeronautics and Space Administration (NASA): Operations and Programmatic Support Services (OPSS)**

TSI provided administrative, professional, and communications support services across a wide range of activities at NASA Headquarters while managing a team of experts on high visibility programs. We managed four subcontractors including one large significant subcontractor.

### **Federal Emergency Management Agency (FEMA): National Flood Insurance Program Financial Management Services**

TSI provides all accounting and financial control functions for the NFIP program. TSI provides support for records management, accounting, financial management, reporting, and audits. We also provide actuarial support to review and analyze FEMA policy and rate setting responsibilities.

### **Department of Homeland Security (DHS) Countering Weapons of Mass Destruction Office: Technical Assistance Team Support (TATS)**

TSI trained first responders, mostly FBI agents, on the use of technical equipment designed to detect weapons of mass destruction a part of natural and man-made incident responses. This program enhanced the Counter Weapons of Mass Destruction (CWMD) capabilities against the use of chemical, biological, radiological, and nuclear material as weapons.

### **Missile and Space Intelligence Center (MSIC): Logistics, Warehouse, Access Control, and Escort Services**

TSI provided logistics support, financial support services, security specialists, intelligence support, mail screening security services, personnel security, and Special Access Program Facility (SAPF) or Sensitive Compartmented Information Facility (SCIF) security administration to MSIC.

### **Air Force Medical Readiness Agency (ARMRA)**

TSI supports four contracts for strategic planning; electronic health record integration, transition, and sustainment; health plan management and training; and external workload capture.

### **US Army: Electronic Warfare Training and Range Support Services**

TSI provided training development; classroom, field, and range training; and range operation and support services for the US Army Cyber Center of Excellence (CCoE). This project focused on providing instruction of the 17E Advanced Individual Training, and Electronic Warfare range operations, and also supported EW course content updates and revisions.
